Digital receipts are eligible for this Sweepstakes. Entrant must then visit www.WinWithZiploc.com ("Website") and select "Disney Frozen", "Disney Frozen II" or "Star Wars" based on his/her Qualifying Purchase. An eligible entrant must then follow the links and instructions to complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, and date of birth. The entrant must then follow the on-screen prompts and upload a photograph of the original receipt showing the Qualifying Purchase. The file must be in .JPEG, .JPG, .PNG, or .GIF format (no PDFs will be accepted) and may not exceed 8 MB. Following this method of entry, an entrant will receive one (1) entry into the applicable Monthly Entry Period and one (1) entry into the applicable Weekly Entry Period for the respective pool either Star Wars pool ("Star Wars Pool"), Frozen Pool ("Frozen Pool"), or Frozen II pool ("Frozen II Pool") based on his/her selection upon registration. For Weekly Entry Periods 1–14 entrants will be entered into the Frozen Pool or Star Wars Pool based on his/her Qualifying Purchase of either Frozen products or Star Wars products, for Weekly Entry Periods 15-27, entrants that that select Star Wars or Frozen based on his/her Qualifying Purchase will receive one (1) entry into a Frozen/Star Wars combined pool ("Frozen/Star Wars Pool") and entrants that select Frozen II based on his/her Qualifying Purchase will receive one (1) entry into the Frozen II Pool, and for Weekly Entry Periods 28-53 entrants that that select Frozen or Frozen II based on his/her Qualifying Purchase will receive one (1) entry into a Frozen/Frozen II combined pool ("Frozen/Frozen II Pool") and entrants that select Star Wars based on his/her Qualifying Purchase will receive one (1) entry into the Star Wars Pool. For Monthly Entry Period 3 only, entrants will receive one (1) entry into either the Star Wars Pool or the Frozen Pool based on his/her selection upon registration. There is a limit of one (1) receipt upload per day during the Sweepstakes Period.

Special Offer: Entrants who upload a Qualifying Purchase receipt to enter the Sweepstakes as outlined above will be sent one (1) music download for either a Frozen or Star Wars themed song (song based on Qualifying Purchase) ("Offer Item"). Available song downloads determined by Sponsor in its sole discretion and are subject to change. Offer Items will be e-mailed to eligible entrants with instructions on how to claim Offer Item. The approximate value of each Offer Item is \$1.29. Limit: one (1) Offer Item per verified Qualifying Purchase receipt.

B. Mail-In Without Making a Purchase: To earn a Sweepstakes entry without making a purchase, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. For Monthly Entry Period 3 only, entrants will receive one (1) entry into either the Star Wars Pool or the Frozen Pool based on his/her selection.

All Mail-In Entries must be postmarked by and received by the dates indicated in the chart above in Section 1. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, and Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. On or around the date indicated in the chart above in Section 1, the Administrator will randomly select two (2) potential grand prize winners for Monthly Entry Period 3 (one [1] for the Star Wars Pool and one [1] for the Frozen Pool). There will be a total of thirteen (13) potential grand prize winners. On or around each Weekly Entry Period drawing date indicated in the chart above in Section 1, the Administrator will randomly select winners from all eligible entries received for each respective Weekly Entry Period.
